Deciding on Membership – Membership is optional with FieldComm Group. 1. **Intellectual Property Rights License (if applicable)** – Members are granted a license to utilize the intellectual property of FieldComm Group as a benefit of membership. In general, this license is required for IP related to FDI, FOUNDATION Fieldbus and HART technologies.
